Guidelines for Contributors

Social Policy Worldwide is a forum for information, exchange, and public debate on **social policy**, **inequalities**, and **social cohesion**.

We seek to foster **global conversations** and inter-regional dialogue among researchers, practitioners, and audiences interested in social issues. Articles are disseminated across our community of experts, researchers, and practitioners of global social policy. We also seek to position the views of international social policy experts in **public debate** on current and urgent issues.

We look for **original, engaging short essays** that showcase new research or findings, reflect on contemporary debates, and introduce critical analyses of pressing social issues. We welcome contributions that focus on one country or area, or that draw comparisons across countries and regions.

Format

Articles should aim for up to **1,200 words** and can include one copyright-free graphic or table. They can include subheadings or section subtitles.

Symposium pieces belong to a series around a specific topic. They must be shorter than 800 words and are drafted as responses or exchanges, actively engaging with previous pieces in the series. They can be invited or proposed by potential contributors.

Both types of entries should present and discuss **one central argument** and avoid scientific jargon. If you use field-specific language, make sure to explain its meaning in the text. Please strive for clarity, avoid long or complex sentences, and state your arguments in simple and compelling words – this is the best way to reach your readers.

References should be used to support factual information or to point to additional sources that expand on a specific point or argument. Their goal should be to allow the reader to reconstruct your argument or to be able to read more on a particular issue, if desired. Please cite your references through **parenthetical citations** and include a hyperlink to the cited reference. Footnotes are not accepted. Please feel free to cite academic research, but also reports, news outlets, and other trusted sources of information.

Articles based on the author's own research should include an explicit reference to the original data source and arguments.

Editing and Publishing Process

Please submit your contribution in **one Word or .odt file**, without formatting, including one title of max. 10 words and an abstract of max. 30 words. In the following page, include your **name** as you wish it to appear on the website and a **bio** of max. 50 words in the same document.

If available, please include also the URL to your **personal website** or online profile, and your personal **Twitter handle**. If you want your **institution(s)** tagged in the Twitter posts promoting your blog entry, please also include their hands. In the same email, please attach also one **press photograph** with copyright information.

All contributions are screened for pertinence, style, and structure. They might be subject to **copyediting** for style, format, and standardized language if needed, without altering the argumentative structure of the text. Blog articles might be submitted for external review and fact-checking.

Proposed changes will be submitted with an estimated **turnaround of 10 days** with a proposed date for publication and a **Contributor Agreement**. Authors should aim to complete revisions and resubmit within 10 days.
